1. The Vice-Chancellor (Chairperson) thanked the participants for making it convenient to participate in the 3<sup>rd</sup> Academic and Activity Council (AAC) meeting conducted via circulation through email due to the Covid-19 Lockdown restrictions.

**ITEM 1 : FEES STRUCTURE FOR OUTSTANDING SPORTSMEN**

2. The fees structure after approval by the Executive Council was put up to the Govt. under the provisions of Section 11(5) of the University Act to approve as the Governing Body authorised to do so under Section 6(1) (xx) has not been constituted. The Sports Minister while approving the fees structure for all the courses instructed to "consider higher fees exemption to the outstanding sportsmen in line with the other universities". It has been decided that the '**Outstanding Sportspersons**' will be granted the following exemptions :-

- 1) **Complete Fee except :-**
  - (a) Registration Fee of Rs. 1000/- for fresh admissions.
  - (b) Caution Money (Refundable) of Rs. 2000/- per annum.
  - (c) Identity Card and Magazine fee of Rs 100 each.
- 2) **Complete Hostel charges for the top 10 'Outstanding Sportspersons' only.**
- 3) **Boarding Charges shall be paid by all students; however, the University may bear expenses on extra diet for the outstanding sportspersons, whenever necessary.**
3. The following will be considered as Outstanding Sportspersons:-
  - 1) For Undergraduate Courses, the top three position holders at the National and State Level Competitions.
  - 2) For Post- Graduation courses, the top three position holders at the Inter-University Games/ National Level Competitions.
4. A Committee formed at the University level will decide the sportspersons to be exempted hostel fees, provided extra diet and other related details.





5. **Decision:** - The AAC approved the fees structure for outstanding sportsmen.

**ITEM 2: POST MATRIC SCHOLARSHIP TO STUDENTS BELONGING TO  
SCHEDULED CASTES FOR STUDIES IN INDIA**

6. The MBSPSU will follow the Scheme for Post Matric Scholarship to Students belonging to Scheduled Castes issued by the Govt. of India and Govt. of Punjab from time to time.

7. **Decision.** The AAC members ratified the University proposal.

**ITEM 3 : DISTRIBUTION OF SEATS BASED ON RESERVATION POLICY**

8. The Govt. has approved the reservation policy as recommended by the Executive Council in the meeting held on 21 July 2020. Based on the above policy, the distribution of seats for course strengths has been worked out as follows:-

- 1) **For Courses having Seats more than 30.**
  - (a) Schedule Caste/Scheduled Tribes SC/ST : 25%
  - (b) Backward Class (OBC): 10%.
  - (c) Border and Backward Area: 2% (1% each) .
  - (d) Sportspersons (3%) & Children/Grand Children of Freedom Fighters of Punjab, Terrorist Affected Persons and Sikh Riot Affected Persons (3%) : 6%.
  - (e) Children /Widows of Defence Personnel, Para-Military Forces Personnel (2%) & Disabled Persons (Blind/Deaf & Dumb/Other handicapped) (4%) : 6%
- 2) **For Courses having Seats up to 30.**
  - (a) Schedule Caste/Scheduled Tribes SC/ST : 25%
  - (b) Backward Class (OBC): 10%.
  - (c) Border and Backward Area : 2% (1% each)
  - (d) Sportspersons: 3%.
  - (e) Children/Grand Children of Freedom Fighter of Punjab, Terrorist Affected Persons and Sikh Riot Affected Persons (3%); Disabled Persons (Blind/Deaf & Dumb/Other handicapped) (3%) & Children /Widows of Defence Personnel, Para-Military Forces Personnel (2%): 8%.

9. **Decision:** The AAC members approved the agenda item as proposed.
